



## Participant/Minor Waiver, Release, Indemnification of All Claims & Covenant Agreement

**NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. Read this document carefully and in entirety. By signing this agreement, you give up your right and the named minor's right to bring a court action to recover compensation or obtain any other remedy for any personal injury or property damage however caused arising out of the named minor's participation in PINE SPRINGS CAMP INC Programs, now or any time in the future.**

### Acknowledgment of Risk

I, in my legal capacity as the parent/guardian of the minor named below, do hereby acknowledge and agree that participation in activities comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with a **Pine Springs Camp program**, participation, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with a **Pine Springs Camp program** participation and that said list in no way limits the operation of this Agreement.

I/my child recognize the fact that there is an inherent danger in these types of activities, even though safety systems are provided. These risks may result in serious injury or death, and include but are not limited to: 1) Falls; 2) Risk associated with climbing or down climbing; 3) Equipment failure; 4) My child's and/or other children's physical condition, sense of balance, decision making, and the ability to follow or give directions; 5) Failure on my child's part to disclose a medical condition and/or physical activity concern that my child may have. I my acknowledge that certain foreseeable and unforeseeable events can contribute to the unpredictability of the activity, such that personal property may be damaged or lost, and that wearing appropriate clothing and footwear are basic safety precautions; 6) Risk associated with transportation to offsite activities; 7) Risk associated with participating in aquatic activities.
